AN ACT TO ALLOW THE TOWN OF CORNELIUS AND THE CITY OF CHARLOTTE TO USE DESIGN-BUILD DELIVERY METHODS AND TO SPECIFY THE INVESTMENT AUTHORITY OF THE TOWN OF CORNELIUS. Summarized in *Daily Bulletin* 3/23/11, 6/8/11, 6/14/11, and 6/16/11 . Enacted June 18, 2011. Effective June 18, 2011.
