SUMMARIES OF AMENDMENTS AND COMMITTEE SUBSTITUTES

HOUSE BILLS

H 964. NC LONGITUDINAL DATA SYSTEM. Filed 5/16/12. Senate amendment makes the following change to 3rd edition, as amended.

Amendment #2 modifies proposed subdivision (43) of GS 105-259(b), to clarify disclosure of certain information to the NC Longitudinal Data System.

Education

SENATE BILLS

S 105. <u>INCREASE PENALTIES/MURDER AND DWI DEATHS</u> (NEW). Filed 2/22/11. Conference report recommends the following changes to 2nd edition to reconcile matters in controversy.

Adds whereas clauses declaring that the state must prove malice to obtain a second degree murder conviction, recognizing that North Carolina case law provides that malice may be shown in three different ways, and enumerates the three different ways of showing malice.

Amends proposed GS 14-17(b) to define second degree murder as any murder other than that which is defined as first degree murder in GS 14-17(a) or murder of an unborn child in GS 14-23.2. Declares that any person who commits second degree murder is to be punished as a Class B1 felon; however, clarifies the exceptions that permit a person convicted of murder in the second degree to be punished as a Class B2 felon.

Amends GS 20-141.4(b) regarding felony death by vehicle as follows: (1) makes repeat felony death by vehicle a Class B2 felony, (2) directs the court to sentence a defendant convicted of aggravated felony death by vehicle in the aggravated range of the appropriate Prior Record Level in spite of the provisions of GS 15A-1340.17, and (3) makes felony death by vehicle a Class D (was, Class E) felony and authorizes intermediate punishment for a defendant who is a Prior Record Level 1 offender notwithstanding the provisions of GS 15A-1340.17. Makes a conforming change to GS 20-141.4(a6). Amends the title to reflect added bill content.

Effective December 1, 2012, and applies to offenses committed on or after that date.

Criminal Law, Procedure, and Sentencing

S 382. AMEND WATER SUPPLY/WATER QUALITY LAWS (NEW). Filed 3/21/11. House committee substitute makes the following changes to 2nd edition.

Deletes all the provisions in the previous edition and replaces them with AN ACT TO PROVIDE WATER AND SEWER SERVICE IN A DESIGNATED URBAN GROWTH AREA AND TO DELAY THE IMPLEMENTATION DEADLINE FOR LOCAL STORMWATER MANAGEMENT PROGRAMS UNDER THE JORDAN LAKE NEW DEVELOPMENT RULE.

Enacts new GS 160A-329, prohibiting a city from denying water and sewer service to a property owner in an urban growth area for reasons not applied to property owners within the city's corporate limits. Permits the city to charge the property owner up to twice the rate for services and the cost of necessary infrastructure improvements.

Sets out directives regarding a specified rule for Jordan Lake new development, including delaying the implementation of a local stormwater management program until the later of August 10, 2013, within three months of the date when the Rules Review Commission approves a local program, or when the Division of Water Quality first renews a NPDES stormwater permit.

S 821. <u>STUDY AND AMEND FISHERIES LAWS</u>. Filed 5/17/12. House committee substitute makes the following changes to 3rd edition.

Among other things, previous version directed specified entities to study the reorganization of fish and wildlife management in the state. New version directs those entities to study the reorganization of *fisheries management* in the state. Makes conforming changes.

Agriculture, Environment, and Natural Resources

S 828. <u>UNEMPLOYMENT INSURANCE CHANGES</u>. Filed 5/17/12. Conference report recommends the following change to 5th edition to reconcile matters in controversy.

Restores a provision, previously deleted by amendment, stating that any executive order issued by the Governor to extend unemployment insurance benefits is void ab initio, unless authorized by the General Assembly or the U.S. Congress. Applies retroactively to January 1, 2012.

Employment and Retirement

S 951. <u>CLEVELAND CTY. PROP TRANSFER/ABC DEF</u>. (NEW). Filed 5/30/12. House committee substitute makes the following changes to 2nd edition.

Corrects the identification of the parcel to be conveyed by the state to the Board of Trustees of Cleveland Community College. Effective July 1, 2014.

Rewrites GS 18B-101(7b) to amend the definition of a *historic ABC establishment*. Makes conforming changes to the title.

Except as otherwise indicated, effective when the act becomes law.
