SUMMARIES OF AMENDMENTS AND COMMITTEE SUBSTITUTES

HOUSE BILLS

H 719. OMNIBUS LOCAL ELECTION LAWS (NEW). Filed 4/6/11. Senate committee substitute makes the following changes to 2nd edition. Deletes the provisions of the 2nd edition and replaces it with AN ACT TO REDISTRICT THE DISTRICT SEATS ON THE BOARD OF COMMISSIONERS OF MECKLENBURG COUNTY, TO MAKE ELECTIONS FOR THE LENOIR COUNTY BOARD OF EDUCATION NONPARTISAN, TO RESTRUCTURE THE BOARD OF COMMISSIONERS OF GUILFORD COUNTY, AND TO LIMIT ALTERATION OF THE BUNCOMBE BOARD OF COUNTY COMMISSIONERS.

Requires that the Mecklenburg County Board of Commissioners (Mecklenburg Board) be made up of nine elected commissioners with three elected at-large and six elected to the six specified districts, in 2012 and biennially thereafter. Prohibits the structure of the Mecklenburg Board from being altered under Part 4 (Modification in the Structure of the Board of Commissioners) of GS Chapter 153A, Article 4, before the return of the 2020 census.

Requires the Lenoir County Board of Education to be elected on a nonpartisan basis and sets timing for election and filing notice of candidacy. Provides that this is effective January 1, 2012, and applies to elections occurring on or after that date, if before January 1, 2012, the US District Court for the Eastern District of North Carolina has approved modification of the consent order in a specified case to allow nonpartisan elections. Provides that if the court approves modification of the consent order in that case to allow nonpartisan elections after January 1, 2012, the section is effective immediately and applies to elections occurring on or after January 1 of the following year.

Repeals SL 1991-136 (An Act to Expand and Redistrict the Guilford County Board of Commissioners), as reenacted by SL 1993-521 and repeals SL 2011-172 (An Act to Restructure the Guilford County Board of Commissioners). Sets the Guilford County Board of Commissioners (Guilford Board) at nine members effective on the first Monday of December 2012. Members are to be elected on a partisan basis from each of eight singlemember districts established in the act, with one additional member elected at large. Members are to be elected to four year terms. Allows the Guilford Board to revise the districts after the return of the 2020 Census. Prohibits the structure of the Guilford Board from being altered under Part 4 (Modification in the Structure of the Board of Commissioners) of GS Chapter 153A, Article 4, before July 1, 2017.

Amends Section 1 of SL 2011-81 to prohibit the Buncombe County Board of Commissioners from being altered under Part 4 (Modification in the Structure of the Board of Commissioners) of GS Chapter 153A, Article 4, before the return of the 2020 Census.

H 719. OMNIBUS LOCAL ELECTION LAWS. Filed 4/6/11. Senate amendment makes the following changes to 3rd edition. Clarifies that the requirements in the act for the election of the members of the Mecklenburg County Board of Commissioners are notwithstanding SL 1993-167 (An Act to Change the Manner of Election of the Charlotte Mecklenburg Board of Education to Provide for District and At-Large Election, with Nonpartisan Plurality Elections in the Odd-Numbered Year, and to Use the Same Districts for Election of the Mecklenburg County Board of Commissioners, All Subject to a Referendum).

H 937. <u>LEWIS DOLLAR DOCKHAM 3</u> (NEW). Filed 7/19/11. Senate committee substitute makes the following changes to 2nd edition.

Moves specified portions of Beaufort County and Craven County from District 6 to District 3. Moves specified portions of Wayne County from District 4 to District 21. Moves a specified portion in Wayne County from District 21 to District 4. Moves specified portions of Sampson County from District 21 to District 22. Moves specified portions of New Hanover County from District 18 to District 20. Moves specified voting tabulation district of New Hanover County from District 20 to District 18. Moves specified portions of Robeson County from District 47 to District 48. Moves other specified portions of Robeson County from District 48 to District 47 and from District 47 to District 46. Moves specified portions of Alamance County from District 64 to District 63, and moves other specified portions from District 64. Moves specified portions of Montgomery County from District 67 to District 66, and moves other specified portions from District 67. Moves specified portions of Union County from District 68 to District 69, and moves other specified portions from District 68 to District 68. Moves specified voting tabulation district in Buncombe County from District 116 to District 115. Moves specified portions in Buncombe County from District 116, and moves other specified portions from District 115 to 116.

H 937. <u>LEWIS DOLLAR DOCKHAM 3</u>. Filed 7/19/11. Senate committee amendment makes the following change to 3rd edition. Moves specified portions of Sampson County from District 22 to District 21.

SENATE BILLS

S 315. ROADSIDE CAMPAIGN SIGNS. Filed 3/10/11. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Amends proposed GS 136-32(f) to allow a city to prohibit or regulate the placement of political signs on rights-of-way of streets that are located within the city's corporate limits and maintained by the city (was, only required that the streets be located within the city's corporate limits). Makes a conforming change. Removes provision that the definitions of *highway* and *street* in GS 20-4.01 apply. Changes the effective date of the act from January 1, 2012 to October 1, 2011.

Elections Law; Transportation

S 453. RUCHO-LEWIS CONGRESS 3 (NEW). Filed 3/29/11. House committee substitute makes the following changes to 2nd edition.

Moves a specified voting tabulation district in Greene County from District 3 to District 1. Moves specified portions of Pitt County from District 1 to District 3, and moves other specified portions from District 3 to District 1. Moves specified portion of Iredell County from District 5 to District 9. Moves specified portions of Guilford County from District 12. Moves specified portions of Buncombe County from District 10 to District 11, and moves other specified portions from District 11 to District 10.

SL 2011-402 (S 455). RUCHO SENATE 2. AN ACT TO REALIGN THE NORTH CAROLINA SENATORIAL DISTRICTS FOLLOWING THE RETURN OF THE 2010 FEDERAL DECENNIAL CENSUS. Summarized in Daily Bulletin 3/29/11 and 7/24/11. Enacted July 27, 2011. Effective July 27, 2011, and applies to elections held on or after January 1, 2012.
