## SUMMARIES OF BILLS FILED

### *Public Bills*

#### **SENATE BILLS**

**S 793. [ADJOURNMENT RESOLUTION](#).** Filed 11/7/11. *FURTHER ADJOURNING THE 2011 REGULAR SESSION OF THE GENERAL ASSEMBLY TO DATES CERTAIN AND LIMITING THE MATTERS THAT MAY BE CONSIDERED UPON RECONVENING.*

Provides that the Senate and the House of Representatives (House) will adjourn on November 8, 2011 and reconvene on Sunday, November 27, 2011 at 8:00 PM. Limits the matters that may be considered during the reconvened session to the following: (1) US Congress and General Assembly redistricting and related matters, as listed; (2) veto overrides on bills returned by the Governor; (3) election laws bills; (4) bills concerning a Tribal Compact; (5) bills addressing natural disasters; (6) appointment bills; (7) adoption of conference reports for bills in conference as of September 14, 2011; (8) local bills pending in the House Rules Committee on July 28, 2011; (9) a bill to modify governance and management provisions for local management entities; (10) concurrence in any committee substitute or amendment; and (11) a joint resolution further adjourning the 2011 Regular Session to a date certain.

Provides that the Senate and the House will adjourn on Tuesday, November 29, 2011, and reconvene on Thursday, February 16, 2012, at noon; also provides that the Senate and the House will adjourn on Saturday, February 18, 2012, and reconvene on Monday, April 23, 2012. Limits the matters that may be considered during the February and April sessions to the following: (1) US Congress and General Assembly redistricting and related matters, as listed; (2) veto overrides on bills returned by the Governor; (3) election laws bills; and (4) a joint resolution further adjourning the 2011 Regular Session to a date certain.

Provides that when the Senate and House adjourn on Wednesday, April 25, 2012, they will reconvene on Wednesday, May 16, 2012, at noon for the regular session. Specifies that the following matters may be considered during the regular session: (1) bills affecting the budget, as described, provided the bill is submitted to the Bill Drafting Division by May 18, 2012, and introduced in the House or filed for introduction in the Senate by May 29, 2012; (2) bills amending the NC Constitution; (3) bills and resolutions introduced in 2011 that passed the crossover deadline [Senate Rule 41; House Rule 31.1(h)]; (4) bills and resolutions implementing recommendations of specified commissions and committees, provided the bill is submitted to the Bill Drafting Division by May 16, 2012, and filed for introduction in the Senate or introduced in the House by May 23, 2012; (5) any noncontroversial local bill, as described, that is submitted to the Bill Drafting Division by May 23, 2012, and introduced in the House or filed for introduction in the Senate by May 30, 2012; (6) selection, appointment, or confirmation of state board and commission members; (7) any matter authorized by joint resolution; (8) a joint resolution authorizing the introduction of such a bill; (9) any bill affecting state or local pension or retirement systems, provided the bill is submitted to the Bill Drafting Division by May 23, 2012, and introduced in the House or filed for introduction in the Senate by May 30, 2012; (10) joint, House, or Senate resolutions authorized under Senate Rule 40(b) or House Rule 31; (11) bills concerning redistricting; (12) bills vetoed by the Governor, to consider overriding the veto; (13) election law bills; (14) bills to disapprove rules under GS 150B-21.3 [effective date of rules provision under Administrative Procedure Act]; and (15) a joint resolution adjourning the 2011 Regular Session, sine die.

Permits the Speaker of the House or the President Pro Tempore of the Senate to authorize committees or subcommittees to meet during the interims between sessions to perform three listed functions.

House committee substitute deletes all provisions of the 1st edition and replaces with *A CURATIVE ACT OF THE GENERAL ASSEMBLY TO ASSIGN ALL AREAS INADVERTENTLY UNASSIGNED BY SESSION LAW 2011-169, AN ACT TO PROVIDE GEOGRAPHIC PARITY IN REPRESENTATION ON THE GREENE COUNTY BOARD OF COMMISSIONERS, AND TO CLARIFY THE TEXTUAL EXPLANATION OF THE DISTRICTING PLAN FOR THE GREENE COUNTY BOARD OF COMMISSIONERS.*

Adds specified Census blocks in Greene County to District 5 for the Greene County Board of Commissioners.

House committee substitute deletes all provisions of the 1st edition and replaces with *A CURATIVE ACT OF THE GENERAL ASSEMBLY TO ASSIGN ALL INADVERTENTLY UNASSIGNED AREAS BY SESSION LAW 2011-203, AN ACT TO REALIGN THE DISTRICTS FOR WAKE COUNTY SUPERIOR COURT JUDGE SEATS TO PROVIDE FOR SINGLE MEMBER*

*DISTRICTS AND EQUAL REPRESENTATION IN THOSE DISTRICTS, AND TO CLARIFY THE TEXTUAL EXPLANATION OF THE PLAN FOR WAKE COUNTY SUPERIOR COURT JUDGES.*

Amends GS 7A-41(b)(4), as amended by SL 2011-203, to add specified Census blocks to Wake County Superior Court District 10B. Effective January 1, 2013, and applies to the 2012 election.

House committee substitute deletes all provisions of the 1st edition and replaces with *A CURATIVE ACT OF THE GENERAL ASSEMBLY TO ASSIGN ALL AREAS INADVERTENTLY UNASSIGNED BY SESSION LAW 2011-404, AN ACT TO REALIGN NORTH CAROLINA HOUSE OF REPRESENTATIVES DISTRICTS FOLLOWING THE RETURN OF THE 2010 FEDERAL DECENNIAL CENSUS, AND TO CLARIFY THE TEXTUAL EXPLANATION OF THE PLAN FOR THE NORTH CAROLINA HOUSE OF REPRESENTATIVES DISTRICTS.*

Adds specified Census blocks to North Carolina House of Representatives Districts as follows. ## **SENATE BILLS**

**S 283. SENATE CURATIVE (NEW).** Filed 3/9/11. Senate committee substitute makes the following changes to 1st edition. Deletes all provisions of the 1st edition and replaces it with *A CURATIVE ACT OF THE GENERAL ASSEMBLY TO ASSIGN ALL AREAS INADVERTENTLY UNASSIGNED BY SESSION LAW 2011-402, AN ACT TO REALIGN THE NORTH CAROLINA SENATORIAL DISTRICTS FOLLOWING THE RETURN OF THE 2010 FEDERAL DECENNIAL CENSUS, AND TO CLARIFY THE TEXTUAL EXPLANATION OF THE PLAN FOR NORTH CAROLINA SENATORIAL DISTRICTS.*

Provides that the purpose of this act is to (1) correct a computer coding error that caused certain Census blocks to not be assigned to any district in the textual explanation of SL 2011-402 and (2) conform the textual explanation of the North Carolina Senatorial districting plan to the actual legislative intent as shown by the districting map and the supporting block assignment file statistics reviewed by the General Assembly in July 2011.

Amends GS 120-1, as amended by SL 2011-402, to include additional census blocks in the following Districts in the following specified counties: District 4 (Wilson); District 5 (Lenoir, Pitt); District 7 (Lenoir, Wayne); District 9 (New Hanover); District 10 (Johnston); District 11 (Johnston, Wilson); District 12 (Johnston); Districts 14, 16, 17, & 18 (Wake); Districts 19 & 21 (Cumberland); Districts 20 & 22 (Durham); Districts 27 & 28 (Guilford); Districts 31 & 32 (Forsyth); and Districts 37, 38, 39, 40, & 41 (Mecklenburg).

Deletes provisions that permitted any area in the state not specifically assigned to a district to be deemed assigned to a surrounding district or contiguous area based on certain specified criteria. Instead directs the Legislative Services Officer (LSO) to certify a true copy of the block assignment file associated with any mapping software used to meet the provisions of GS 120-1(a) to apportion senatorial districts. Requires the LSO to deliver the certified copy of the block assignment file to the Principal Clerk of the Senate, and directs that if any area is not assigned to a specific district as identified in GS 120-1(a), the placement of the area in a district is to be subject to the certified true copy of the block assignment file delivered to the Principal Clerk of the Senate.

Applies to elections held on or after January 1, 2012.

**S 689. CONGRESSIONAL CURATIVE (NEW).** Filed 4/19/11. Senate committee substitute makes the following changes to 1st edition. Deletes all provisions of the 1st edition and replaces it with *A CURATIVE ACT OF THE GENERAL ASSEMBLY TO ASSIGN ALL AREAS INADVERTENTLY UNASSIGNED BY SESSION LAW 2011-403, AN ACT TO REALIGN THE UNITED STATES CONGRESSIONAL DISTRICTS FOLLOWING THE RETURN OF THE 2010 FEDERAL DECENNIAL CENSUS, AND TO CLARIFY THE TEXTUAL EXPLANATION OF THE PLAN FOR THE UNITED STATES CONGRESSIONAL DISTRICTS.*

Provides that the purpose of this act is (1) to correct a computer coding error that caused certain Census blocks to not be assigned to any district in the textual explanation of SL 2011-403 and (2) to conform the textual explanation of the United States Congressional districting plan to the actual legislative intent as shown by the districting map and the supporting block assignment file statistics reviewed by the General Assembly in July 2011.

Amends GS 163-201, as amended by SL 2011-403, to include additional census blocks in the following Districts in the following specified counties: District 1 (Lenoir, Washington, & Wilson); District 2 (Harnett); District 3 (New Hanover & Pitt); District 4 (Cumberland & Wake); District 8 (Davidson); District 9 (Iredell, Mecklenburg, & Union); and District 12 (Guilford).

Deletes provisions that permitted any area in the state not specifically assigned to a district to be deemed assigned to a surrounding district or contiguous area based on certain specified criteria. Instead directs the Legislative Services Officer (LSO) to certify a true copy of the block assignment file associated with any mapping software used to meet the provisions of GS 163-201(a), which apportions congressional districts. Requires the LSO to deliver the certified copy of the block assignment file to the Principal Clerk of the Senate and the Principal Clerk of the House of Representatives, and directs that if any area is not assigned to a specific district as identified in GS 163-201(a), the placement of the area in a district is to be subject to the certified true copy of the block assignment file delivered to the Principal Clerks of the Senate and of the House.

Effective when the act becomes law and applies to elections held on or after January 1, 2012.
