PUBLIC/HOUSE BILLS

H 115 (2013-2014) STATE MINIMUM WAGE/INFLATION INCREASES. Filed Feb 14 2013, A BILL TO BE ENTITLED AN ACT PROVIDING FOR AUTOMATIC ADJUSTMENT OF THE STATE'S MINIMUM WAGE BASED UPON INCREASES IN THE CONSUMER PRICE INDEX.

Amends GS 95-25.3 to add a new subsection (a1) that requires the minimum wage to be increased on January 1, 2014, and every January 1 thereafter, by the cost of living as measured by the percentage increase of the consumer price index calculated by the US Department of Labor. Requires the Commissioner of Labor to calculate the indexed minimum wage. Effective when the act becomes law.

H 117 (2013-2014) REVISE LAWS FOR UNOCCUPIED SCHOOL BUSES. Filed Feb 18 2013, A BILL TO BE ENTITLED AN ACT TO MODIFY THE SPEED LIMIT FOR A SCHOOL BUS WITH NO CHILD PASSENGERS ON BOARD.

Under current law it is unlawful for a school bus driver to drive a school bus occupied by one or more children at a rate of speed more than 45 miles and unlawful to drive a school activity bus at a rate of more than 55 miles per hour on the state's highways or public vehicular areas.

Amends GS 20-218(b) as the title indicates. Requires a school bus driver to drive a school bus or a school activity bus no faster than the posted speed limit on public highways or public vehicular areas of the state, providing that there areno child passengers on the school bus or activity bus. Also provides that the driver is not required to use hazard lights when traveling on the interstate when no children are on board.

H 118 (2013-2014) CONSULAR DOCUMENTS NOT ACCEPTABLE AS ID. Filed Feb 18 2013, A BILL TO BE ENTITLED AN ACT TO PROVIDE THAT CERTAIN CONSULATE OR EMBASSY DOCUMENTS MAY NOT BE USED TO DETERMINE A PERSON'S IDENTIFICATION OR RESIDENCE FOR GOVERNMENTAL AND LAW ENFORCEMENT PURPOSES.

Current law provides that a matricula consular (Consular Identification Card) issued by the Mexican Consulate for North Carolina, or a substantially similar documentissued by the consulate or embassy of another country, is acceptable as a reasonably reliable indicator of residency for specified purposes.

Adds new Article 18, *Identification Documents*, to GS Chapter 15A, enacting new GS 15A-306 todeclare thatdocuments issued by a consulate or embassy of another country, including the matricula consular, are no longer acceptable to useasanidentification card or as an indicator of residency by a justice, judge, clerk, magistrate, law enforcement officer, or other government official.

Prohibits any local government from establishing by policy or ordinancethe use of amatricula consularor similar document issued by a consulate or embassy of another country as a form of identification to determine the identity or residency of any

person. Repeals any local government policy or ordinance that contradicts this provision of new GS 15A-306.

Makes conforming changes to GS 20-7(b4), GS 58-2-164(c), and GS 106A-55.3(b).

S 14 (SL 2013-1) (2013-2014) INCREASE ACCESS TO CAREER/TECHNICAL ED. Filed Jan 30 2013, A BILL TO BE ENTITLED AN ACT TO DIRECT THE STATE BOARD OF EDUCATION TO DEVELOP CAREER AND COLLEGE ENDORSEMENTS FOR HIGH SCHOOL DIPLOMAS, INCREASE ACCESS TO CAREER AND TECHNICAL EDUCATION TEACHERS IN PUBLIC SCHOOLS, AND TO WORK WITH THE STATE BOARD OF COMMUNITY COLLEGES TO INCREASE THE NUMBER OF STUDENTS ENROLLING IN CAREER AND TECHNICAL EDUCATION IN HIGH NEED EMPLOYMENT AREAS.

A BILL TO BE ENTITLED AN ACT TO DIRECT THE STATE BOARD OF EDUCATION TO DEVELOP CAREER AND COLLEGE ENDORSEMENTS FOR HIGH SCHOOL DIPLOMAS, INCREASE ACCESS TO CAREER AND TECHNICAL EDUCATION TEACHERS IN PUBLIC SCHOOLS, AND TO WORK WITH THE STATE BOARD OF COMMUNITY COLLEGES TO INCREASE THE NUMBER OF STUDENTS ENROLLING IN CAREER AND TECHNICAL EDUCATION IN HIGH NEED EMPLOYMENT AREAS.

S 97 (2013-2014) PROPERTY TAX/DEANNEXATION. Filed Feb 18 2013, A BILL TO BE ENTITLED AN ACT TO REQUIRE RELEASE OF PROPERTY TAXES IN ANY AREA THAT WAS PART OF A MUNICIPALITY FOR SIX MONTHS OR LESS AND THEN DEANNEXED.

Amends Article 12 of GS Chapter 105 by enacting new, GS 105-282.2, requiring a municipality to release or refund any property taxes levied on property within that municipality's corporate limits for six months or less prior to deannexation if no notice of the tax has yet been sent to the taxpayer; eligible taxpayers are not required to apply for the refund or release which must be made pursuant to Article 27 of GS Chapter 105. Effective when the act becomes law.

S 98 (2013-2014) REQUIRE PULSE OXIMETRY NEWBORN SCREENING. Filed Feb 18 2013, A BILL TO BE ENTITLED AN ACT TO EXPAND THE NEWBORN SCREENING PROGRAM ESTABLISHED BY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO INCLUDE NEWBORN SCREENING FOR CONGENITAL HEART DISEASE UTILIZING PULSE OXIMETRY, AS RECOMMENDED BY THE NORTH CAROLINA CHILD FATALITY TASK FORCE.

As the title indicates. Includes whereas clauses identifying data and statistics to support the expansion of the Newborn Screening Program. Amends GS 130A-125 to require the Newborn Screening Program to include a pulse oximetry screening

for each newborn in order to detect congenital heart defects. Directs the Commission for Public Health to adopt temporary and permanent rules to include pulse oximetry screening in the Newborn Screening Program. Specifiesissues that must be addressed by the rules governing pulse oximetry screening.

LOCAL/HOUSE BILLS

H 116 (2013-2014) CARRBORO OFFICE OF ALDERMAN. Filed Feb 18 2013, A BILL TO BE ENTITLED AN ACT TO AMEND THE CHARTER OF THE TOWN OF CARRBORO TO PROVIDE THAT VACANCIES IN THE OFFICE OF ALDERMAN SHALL BE FILLED BY APPOINTMENT IN ACCORDANCE WITH THE NORTH CAROLINA GENERAL STATUTES OR MAY BE FILLED THROUGH A SPECIAL ELECTION PROCESS UNDER CERTAIN CONDITIONS.

Amends Section 2-2 of the Carrboro Town Charter (SL 1987-476, as amended by SL 2007-270) as the title indicates. Does not apply to vacancies in the mayor's office. Makes this act effective when it becomes law and applies to any vacancy on the board of aldermen occurring on or after that date.
