H 36 (2017-2018) [NC IOM STUDY OF EYE CARE ACCESS \(NEW\)](#). Filed Feb 1 2017, *AN ACT TO DIRECT THE NORTH CAROLINA INSTITUTE OF MEDICINE TO STUDY ENHANCED ACCESS TO EYE CARE AND TO REPORT TO THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON HEALTH AND HUMAN SERVICES.*

House committee substitute deletes the provisions of the 1st edition and now provides the following.

Directs the NC Institute of Medicine (NC IOM) to study the issues addressed in HB 36 Enact Enhanced Access to Eye Care Act, as introduced during the 2017 Regular Session of the General Assembly.

Directs NC IOM to report findings and recommendations pertaining to access to eye care, including draft legislation if appropriate, to the Joint Legislative Oversight Committee on Health and Human Services by October 1, 2018.

Makes conforming changes to the act's long and short titles.

H 330 (2017-2018) [CIVPRO/QUALIFIED IMMUNITY FOR AUTO ACCIDENT](#). Filed Mar 13 2017, *AN ACT PROVIDING THAT A PERSON DRIVING AN AUTOMOBILE WHILE EXERCISING DUE CARE IS IMMUNE FROM CIVIL LIABILITY FOR ANY INJURY TO ANOTHER IF THE INJURED PERSON WAS PARTICIPATING IN A PROTEST OR DEMONSTRATION AND BLOCKING TRAFFIC IN A PUBLIC RIGHT-OF-WAY OR HIGHWAY AT THE TIME OF THE INJURY.*

House amendment #2 makes the following changes to the 1st edition as amended.

Adds new subsection (c) to proposed GS 1-539.13, providing that the civil immunity set forth in subsection (a) does not apply if the injured person participating in a protest or demonstration was doing so with a valid permit allowing persons to protest or demonstrate on the public street or highway where the injury occurred.

H 571 (2017-2018) [AUTOMATIC EXPUNCTION/WRONGFUL CONVICTION](#). Filed Apr 5 2017, *AN ACT TO PROVIDE FOR THE AUTOMATIC EXPUNCTION OF A PERSON'S RECORD IF THE PERSON IS WRONGLY CONVICTED, INCARCERATED, AND EXONERATED*.

House amendment #1 makes the following changes to the 2nd edition:

Amends proposed GS 15A-149A. Deletes current subsection (c), regarding the necessary contents of an order of expunction, and replaces them with a provision requiring the order of expunction to include instructions that entries relating to the person's arrest, charge, or trial be expunged from the records of listed governmental entities, and any other government agency identified by the petitioner as bearing record of the same, and an instruction that prior to expunction the files be sent to the Administrative Office of the Courts to be maintained in a confidential file under seal, only to be released as specified. Provides that the expunction is automatic, and the costs of the expunction may not be taxed against the petitioner.

Replaces the word "apprehension" with the word "arrest" at all points in the bill.

House committee substitute makes the following changes to the 1st edition.

Amends proposed subsection (b) in GS 48-9-106, pertaining to the release of an original birth certificate to an adult adoptee. Adds a new provision directing the State Registrar, upon application of the adult adoptee who provides proof of the name of only one biological parent, to give the adult adoptee a certified copy of the adoptee's original birth certificate after redacting the name of the parent for which the adoptee did not provide proof, if applicable. Makes conforming changes. Modifies the application of the new subsection, providing that the subsection only applies to adult adoptees seeking an original birth certificate who are at least 40 years of age upon application (previously, also required adoption on or after January 1, 1977). Makes clarifying technical changes. Changes the act's long title.
