H 927 (2017-2018) [2017 HOUSE REDISTRICTING PLAN A1](#). Filed Aug 18 2017, *AN ACT TO REALIGN THE DISTRICTS FOR THE ELECTION OF THE MEMBERS OF THE NORTH CAROLINA HOUSE OF REPRESENTATIVES*.

House committee substitute makes the following changes to 1st edition.

Amends the short title.

Amends GS 120-2 to establish boundaries for 120 House districts with each district electing one representative to the North Carolina House of Representatives in 2018 and periodically thereafter. Applies to elections held on or after January 1, 2018.
