H 96 (2021) [ALLOW PHARMACISTS TO ADMIN. INJECTABLE DRUGS](#). Filed Feb 16 2021, *AN ACT TO AUTHORIZE IMMUNIZING PHARMACISTS TO DISPENSE, DELIVER, AND ADMINISTER CERTAIN TREATMENT AND MEDICATIONS AND TO REQUIRE PARENTAL CONSENT FOR ADMINISTRATION OF VACCINES UNDER AN EMERGENCY USE AUTHORIZATION TO A MINOR.*

AN ACT TO AUTHORIZE IMMUNIZING PHARMACISTS TO DISPENSE, DELIVER, AND ADMINISTER CERTAIN TREATMENT AND MEDICATIONS AND TO REQUIRE PARENTAL CONSENT FOR ADMINISTRATION OF VACCINES UNDER AN EMERGENCY USE AUTHORIZATION TO A MINOR. SL 2021-110. Enacted Aug. 20, 2021.

Section 1 is effective Feb. 1, 2022. Sections 2, 4, and 7 are effective Oct. 1, 2021. Section 3 is effective Sept. 1, 2021. Section 8 is effective March 31, 2022. The remainder is effective Aug. 20, 2021.
