## **PUBLIC/HOUSE BILLS**

H 917 (2023-2024) GSC TECHNICAL CORRECTIONS 2024. Filed Apr 29 2024, AN ACT TO MAKE TECHNICAL CORRECTIONS TO THE GENERAL STATUTES AND SESSION LAWS, AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION.

Section 1

Amends GS 1-569.17 (witnesses; subpoenas; depositions; discovery), by making clarifying and technical changes.

Section 2

Makes technical changes to GS 7B-2204(d). Removes duplicative reference to juvenile justice section so that it is clear that the only agency that can approve a juvenile's detention in a holdover or detention facility is the Division of Juvenile Justice of the Department of Public Safety (DJJ).

Section 3

Modernizes language in the caption of GS 14-113.7A (application of criminal fraudulent property theft article to financial transaction (currently, credit) cards and makes conforming change from credit card to updated defined term financial transaction card in statute.

Section 4

Repeals Article 15A of GS Chapter 15 (pertaining to investigation of offenses involving abandonment and nonsupport of children).

Section 5

Amends GS 90A-53, concerning qualifications and examination for registration as an environmental health specialist or environmental health specialist intern, as follows. Amends the allowable education and practice experience standards, to now specify among the four options: (1) graduated with a bachelor's or a or postgraduate degree and earned a minimum of 30 semester hours or 45 quarter hours in the physical, biological, natural, life, or health sciences and has one or more years of experience in the field of environmental health practice; or (2) graduated with a bachelor's or postgraduate degree in public health and has one or more years of experience in the field of environmental health practice. Make additional technical changes.

Section 6

Repeals GS 108A-54.3A(a)(2a) (providing Medicaid coverage for certain caretaker relatives).

Section 7

Repeals Article 3 of GS Chapter 110 (pertaining to control over child-caring facilities).

Section 8

Modernizes language, makes technical changes, and makes language gender neutral in GS 110-130 (pertaining to paternity or child support actions by designated representatives of county commissioners).

Section 9

Amends GS 115C-284, as amended by Section 1(d) of SL 2023-125, as follows. Removes the statutory reference to powers of superintendent as part of hiring process of supervisors and principals by local boards of education. Removes selection of principal by election of the board of education of those administrative units upon recommendation of the superintendent of city

schools. Makes conforming changes to indicate that provisions pertaining to the certification of school administrator, the role of the State Board of Education (Board) in the appointment process for supervisory and professional positions, the Board's power to refine certification and other requirements for principals and assistant principals, outdated language, digital teaching requirements, and certain teaching and education prerequisites required for candidacy to principal have been repealed by SL 2023-125. Makes conforming and technical changes and modernizes language.

Makes technical changes to GS 115C-299. Removes language requiring teachers in city administrative units to be elected by the local board of education upon recommendation by the superintendent of city schools.

Repeals GS 115C-315(a) (pertaining to hiring of janitors and maids by local boards of education upon recommendation by the superintendent). Removes outdated language from GS 115C-315(b) and removes reference to the statutory powers of superintendent as part of hiring process of school personnel by local boards of education.

Section 10

Amends GS 116-30.2 (concerning appropriations to special responsibility constituent institutions) by correcting a statutory cross-reference and making technical changes. Amends GS 126-85 (protection from retaliation) by correcting a statutory cross-reference and making technical changes.

Section 11

Amends GS 116-209.28 (pertaining to administration of scholarship by the Principal Fellows Program) to remove outdated language and update term for the NC Principal Fellows Trust Fund to conform with changes to the program set forth in SL 2022-71.

Section 12

Repeals GS 121-42 contained in Article 4, GS Chapter 121 (directing that the article be known as the Conservation and Historic Preservation Agreements Act).

Section 13

Makes technical and clarifying changes, removes outdated language, and updates title of firefighter entity Board of Trustees member to the NC Firefighters' and Rescue Squad Worker's Pension Fund in GS 128-28 (pertaining to administration and responsibility of the Local Government Retirement System [LGERS]). Makes language gender neutral. Narrows the power of the actuary designated by the Board of Trustees in GS 128-28(m) to perform other duties required in connection with GS Chapter 128.

Amends GS 153A-93 (county retirement benefits) and GS 160A-163 (city and town retirement benefits) to update title of firefighter entity to the NC Firefighters' and Rescue Squad Worker's Pension Fund. Makes technical and clarifying changes and removes outdated language from GS 153A-93 and GS 160A-163.

Section 14

Makes technical change to GS 143-215-107F (prohibiting requirements for control of emissions from new motor vehicles).

Section 15

Repeals Article 29A of GS Chapter 143 (the Governor's Council on Employment of the Handicapped).

Section 16

Makes technical change to GS 144-9(b), concerning the disposal of flags.

Section 17

Makes technical and organizational changes to GS 160D-1311 (community development programs and activities).

Section 18

Retroactive to January 1, 2023, makes the following changes. Repeals Section 9A.1(a) of SL 2022-74 (pertaining to rate adjustment dates for State-County special assistance program rates). Increases the basic rate of special assistance payment

rates from \$1,182 per month per resident to \$1,285 per month per resident and the enhanced rate from \$1,515 per month per residence to \$1,647 per resident under GS 108A-42.1.

Section 19

Amends SL 2021-180, Section 9A.3A(a) as follows. Removes requirement that the Department of Health and Human Services (DHHS), Division of Aging and Adult Services apply to the Social Security Administration for approval to allow eligible individuals residing in in home living arrangements to qualify for State County Special Assistance under the Social Security Optional State Supplement Program in the same manner as individuals residing in adult care homes or special care units. Amends Section 9A.3A(d) of SL 2021-180, as amended by Section 9A.1(b) of SL 2022-74 to indicate that the Center for Medicare and Medicaid Services (CMS) approved DHHS's application for Medicaid coverage for individuals residing in inhome living arrangements who qualify for State-County Special Assistance under the Social Security Optional State Supplement Program effective January 1, 2023. Changes the effective date set forth in Section 9A.1.(d) of SL 2022-74 to reflect new effective date of January 1, 2023 (CMS effective date of approval of DHHS application, set forth above).

Makes conforming changes. Changes the effective date to being retroactively effective to January 1, 2023.

Section 20

Amends Section 9H.15(i) of SL 2023-134, retroactive to October 3, 2023, to change effective date of the legislation's amendments to: (1) various components of the NC Child Fatality Prevention System (Article 14 of GS Chapter 7B), except for new provisions pertaining to participation in the National Fatality Review Case Reporting System; and (2) GS 7B-2902 (disclosure in child fatality or near fatality cases) to January 1, 2025.

H 919 (2023-2024) PICKLEBALL WELLNESS INITIATIVE: HEALTH EQUITY. Filed Apr 29 2024, AN ACT TO PROVIDE FUNDS TO NORTH CAROLINA STATE UNIVERSITY FOR A PILOT PROGRAM IN THE STATE TO INCREASE DIVERSITY IN THE GAME OF PICKLEBALL.

Appropriates \$196,362 in nonrecurring funds for 2024-25 from the General Fund to the UNC Board of Governors to be allocated to the Department of Parks, Recreation and Tourism Management in the College of Natural Resources at North Carolina State University for the creation and testing of a Pickleball based wellness initiative to enhance diversity and promote physical and psychosocial well-being through programs located in eastern Wake, Halifax, and Northampton Counties. Explains that the counties were chosen based on population diversity, economic need, and community health assessments. Directs that the initiative consist of six required elements including, interview with Black and Latino residents to gain insight into how to best create and promote programs aimed to promote wellness and increase equity, branding and marketing, pickleball instruction and gameplay, post-program evaluations, and creation of a toolkit so that the program can be replicated throughout the State. Specifies that the funds do not revert. Effective July 1, 2024.

H 920 (2023-2024) FUNDS FOR TRANSYLVANIA FIRE DEPT. SIGNAL. Filed Apr 29 2024, AN ACT TO APPROPRIATE FUNDS FOR THE NORTH TRANSYLVANIA FIRE DEPARTMENT EMERGENCY SIGNAL.

Requires, of the funds appropriated from the Highway Fund to the Department of Transportation for 2024-25, that \$72,000 in nonrecurring funds be used for the installation of the North Transylvania Fire Department Emergency Signal. Effective July 1, 2024.

H 921 (2023-2024) MODIFY MILEAGE AND PER DIEM. Filed Apr 29 2024, AN ACT TO SET 2025 LEGISLATOR MILEAGE AND PER DIEM AT 2023 FEDERAL RATES.

Effective upon the convening of the 2025 General Assembly and applicable to travel occurring on or after that date, amends GS 120-3.1(a) (pertaining to travel and other expenses for members of the General Assembly) as follows. Increases the business standard mileage rate set forth in the weekly travel allowance while in session as well as for occasions when a member travels as a member of the General Assembly or any of its committees or commissions, with the approval of the Legislative Services Commission, so that it is 65.5 cents per mile (currently, the rate is 29 cents per mile as set forth in IRS publication Rev. Proc. 93-57, published on December 27, 1993), in line with IR 2022-234 published on December 29, 2022. Requires members' subsistence allowance for meals and lodging to be at a daily rate equal to the maximum per diem rate for federal employees traveling to Raleigh as set out at 88 Federal Register 56629 (August 18, 2023) (currently, 58 Federal Register 67959, December 22, 1993). Makes conforming changes.

S 777 (2023-2024) FUNDS FOR AMM/URBAN MINISTRIES CLINICS. Filed Apr 29 2024, AN ACT TO APPROPRIATE FUNDS TO THE NORTH CAROLINA ASSOCIATION OF FREE AND CHARITABLE CLINICS TO AID THE ALLIANCE MEDICAL MINISTRY AND URBAN MINISTRIES OPEN DOOR CLINICS.

Appropriates \$100,896 for 2024-25 from the General Fund to the Office of State Budget and Management for a directed grant to the North Carolina Association of Free and Charitable Clinics Inc. to support the salary of one nurse practitioner at both the Alliance Medical Ministry and Urban Ministries Open Door Clinics, which provide healthcare to uninsured residents of Wake County. Effective July 1, 2024.

Appropriates \$107,000 for 2024-25 from the General Fund to the Office of State Budget and Management for a directed grant to Radio Reading Service Inc. to allow the organization to add more employee hours and subscriptions, maintain equipment, and provide supplies for printing. Effective July 1, 2024.

Adds the specified property to the Town of Mount Gilead's corporate limits, effective June 30, 2025. Specifies that property in the specified territory as of January 1, 2025, is subject to municipal taxes for taxes imposed for taxable years beginning on or after July 1, 2025.

S 772 (2023-2024) COMM. COLL. TRUSTEE TERMS/REGION 3. Filed Apr 29 2024, AN ACT TO REALIGN THE TERMS OF OFFICE FOR CERTAIN MEMBERS OF THE BOARDS OF TRUSTEES OF CERTAIN COMMUNITY COLLEGES.

Notwithstanding GS 115D-13 (pertaining to terms of office of the trustees of the boards of trustees for the State's community colleges) as amended by Section 6.10(o) of SL 2023-134, revises the terms of office for the trustees as follows:

- (1) Bladen Community College:
- Of the two terms elected by the Bladen County Board of Commissioners that expire June 30, 2025, requires that board elect one trustee to a two-year term, beginning July 1, 2025, so that the term expires June 30, 2027.
- Of the two terms elected by the Bladen County Board of Commissioners that expire June 30, 2026, requires that board elect one trustee to a two-year term, beginning July 1, 2026, so that the term expires June 30, 2028.
- Of the two terms elected by the Bladen County Board of Education that expire June 30, 2026, requires the General Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of two years, beginning July 1, 2026, so that the term expires June 30, 2028.

• Of the two terms elected by the Bladen County Board of Education that expire June 30, 2027, requires the General Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of two years, beginning July 1, 2027, so that the term expires June 30, 2029.

### (2) Cape Fear Community College

• For the additional term of office elected by the Pender County Board of Commissioners, requires board to elect one trustee to a three-year term, beginning July 1, 2024, so that the term expires June 30, 2027.

### (3) Central Carolina Community College

- Of the two terms elected by the Chatham County Board of Commissioners that expire June 30, 2025, requires that board elect one trustee to a two-year term, beginning July 1, 2025, so that the term expires June 30, 2027.
- Of the two terms elected by the Harnett County Board of Commissioners that expire June 30, 2025, requires that board to (i) elect one trustee to a one-year term, beginning July 1, 2025, so that the term expires June 30, 2026 and (ii) elect one trustee to a three-year term beginning July 1, 2025, so that the term expires June 30, 2028.

### (4) James Sprunt Community College

Of the two terms elected by the Duplin County Board of Commissioners that expire June 30, 2025, requires that board elect one
trustee to a two-year term, beginning July 1, 2025, so that the term expires June 30, 2027.

#### (5) Johnston Community College

- Extends terms of the two named appointees who are appointed by the governor or any persons appointed to fill either seat's vacancy for two years for the seat expiring in 2024, so that the term expires on June 30, 2026, and for one year for the seat expiring in 2026, so that the term expires on June 30, 2027.
- Specifies that the term for the named appointee elected by the Johnston County Board of Commissioners or any person appointed to fill that seat's vacancy, expires on June 30, 2026.
- Specifies that the term for the named appointee elected by the Johnston County Board of Education or any person appointed to fill that seat's vacancy, expires on June 30, 2026.

## (6) Lenoir Community College

Of the one term elected by the Greene County Board of Commissioners that expire June 30, 2025, requires that board appoint
one trustee to a one-year term, beginning July 1, 2025, so that the term expires June 30, 2026.

### (7) Pitt Community College

- Of the two terms elected by the Pitt County Board of Commissioners that expire June 30, 2025, requires that board elect one trustee to a one-year term, beginning July 1, 2025, so that the term expires June 30, 2026.
- Of the two terms elected by the Pitt County Board of Education that expire June 30, 2025, requires the General Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of one year, beginning July 1, 2025, so that the term expires June 30, 2026.

## (8) Sandhills Community College

• For the additional term of office elected by the Hoke County Board of Commissioners, requires board to elect one trustee to a three-year term, beginning July 1, 2024, so that the term expires June 30, 2027.

In line with the GS 115D-12, GS 115D-13, and SL 2023-134, specifies that for Board of Trustees seats where a specific term length is not provided or revised: (1) the term of current seats will expire at the end of its previously appointed or elected terms and (2) the initial term of additional seats to be elected or appointed pursuant to Section 6.10 of SL 2023-134 will begin on July 1, 2024, and expire on June 30, 2028, so to maintain staggered terms.

Specifies that the successors to the trustees elected or appointed to terms of less than four years or whose terms were otherwise revised above will be elected or appointed, following the expiration of their terms, to four-year terms starting on July 1 and

every four years thereafter.

S 773 (2023-2024) HIGH POINT/CONVEYANCE OF REAL PROPERTY. Filed Apr 29 2024, AN ACT TO AMEND THE CHARTER OF THE CITY OF HIGH POINT TO AUTHORIZE THE CITY TO SELL, EXCHANGE, OR OTHERWISE TRANSFER REAL PROPERTY SUBJECT TO RESTRICTIONS.

Identical to H 901, filed 4/24/24.

Adds new section pertaining to the conveyance of real property with restrictions to Article IX of the Charter of the City of High Point, S.L. 1979-501, permitting the City Council, in addition to other authorized means, to approve the sale, exchange, or transfer of the entirety of or any lesser interest in real property, either by public sale or by negotiated private sale in furtherance of adopted City policies or plans for the area. Allows the City to encumber the property being sold in order to further those policies or plans for the area or to make the sale contingent upon necessary rezoning of the property. Permits the price of the property to reflect any of those restrictions. Allows for conveyances to be made only pursuant to a resolution adopted by the Council after at least ten days' notice. Allows for bids or written proposals, including detailed development and site plans for the purchase of any such property or property interest.

S 774 (2023-2024) PROHIBIT CRYPTO-MINING AS AUTHORIZED USE. Filed Apr 29 2024, AN ACT TO ALLOW HENDERSON, POLK, AND RUTHERFORD COUNTIES TO PROHIBIT CRYPTOCURRENCY MINING AS AN ALLOWABLE USE IN ANY ZONING DISTRICT.

Enacts new GS 160D-916.1, allowing the counties of Henderson, Polk, and Rutherford, as well as municipalities within those counties, to regulate or prohibit cryptocurrency mining in any zoning district. Defines cryptocurrency mining as the operation of specialized computer equipment for the primary purpose of mining one or more blockchain-based cryptocurrencies which typically involves the solving of algorithms as part of the development and maintenance of a blockchain that is a type of distributed ledger maintained on a peer-to-peer network.

S 776 (2023-2024) COMM. COLL. TRUSTEE TERMS/REGION 2. Filed Apr 29 2024, AN ACT TO REALIGN THE TERMS OF OFFICE FOR CERTAIN MEMBERS OF THE BOARDS OF TRUSTEES OF CERTAIN COMMUNITY COLLEGES.

Notwithstanding GS 115D-13 (pertaining to terms of office of the trustees of the boards of trustees for the State's community colleges) as amended by Section 6.10(o) of SL 2023-134, revises the terms of office for the following trustees as follows:

### (1) Asheville-Buncombe Technical Community College:

• Of the term elected by the Madison County Board of Commissioners that expires June 30, 2025, requires that board elect one trustee to a one-year term, beginning July 1, 2025, so that the term expires June 30, 2026.

### (2) Blue Ridge Community College

- Of the two terms elected by the Henderson County Board of Commissioners that expire June 30, 2025, requires that board elect one trustee to a three-year term, beginning July 1, 2025, so that the term expires June 30, 2028.
- Of the two terms elected by the Henderson County Board of Commissioners that expire June 30, 2027, requires that board elect one trustee to a three-year term, beginning July 1, 2027, so that the term expires June 30, 2030.
- Of the two terms elected by the Henderson County Board of Education that expire June 30, 2025, requires the General
  Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of three
  years, beginning July 1, 2025, so that the term expires June 30, 2028.
- Of the two terms elected by the Henderson County Board of Education that expire June 30, 2027, requires the General Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of three years, beginning July 1, 2027, so that the term expires June 30, 2030.

## (3) Davidson-Davie Community College

- For the one term elected by the Davidson County Board of Education that expires June 30, 2024, requires the General Assembly, upon the recommendation of the Speaker of the House of Representatives, to appoint one trustee to a term of one year, beginning July 1, 2024, so that the term expires June 30, 2025.
- Of the two terms elected by the Davie County Board of Commissioners that expire June 30, 2026, requires that board elect one trustee to a two-year term, beginning July 1, 2026, so that the term expires June 30, 2028.

## (4) Southwestern Community College

- For the one term elected by the Macon County Board of Commissioners that expire June 30, 2024, requires that board appoint
  one trustee to a one-year term, beginning July 1, 2024, so that the term expires June 30, 2025.
- Of the two terms elected by the Jackson County Board of Commissioners that expire June 30, 2026, requires that board elect one
  trustee to a one-year term, beginning July 1, 2026, so that the term expires June 30, 2027.
- Of the two terms to be elected by the Swain County Board of Commissioners, specifies that board elect one trustee to a two-year term, beginning July 1, 2024, so that the term expires June 30, 2026.

### (5) Tri-County Community College

- Of the two terms elected by the Clay County Board of Commissioners, requires that board to elect (i) one trustee to a one-year term, beginning July 1, 2024, so that the term expires June 30, 2025, and (ii) elect the other trustee to a three-year term beginning July 1, 2024, so that the term expires June 30, 2027.
- Of the two terms to be elected by the Graham County Board of Commissioners, requires that board elect one trustee to a two-year term, beginning July 1, 2024, so that the term expires June 30, 2026.
- For the additional term to be elected by the Cherokee County Board of Commissioners, requires that board elect one trustee to a
  three-year term, beginning July 1, 2024, so that the term expires June 30, 2027.

In line with the amendments to GS 115D-12, GS 115D-13, and SL 2023-134, specifies that for Board of Trustees seats where a specific term length is not provided or revised: (1) the term of current seats will expire at the end of its previously appointed or elected terms and (2) the initial term of additional seats to be elected or appointed pursuant to Section 6.10 of SL 2023-134 will begin on July 1, 2024, and expire on June 30, 2028, so to maintain staggered terms.

Specifies that the successors to the trustees elected or appointed to terms of less than four years or whose terms were otherwise revised above will be elected or appointed, following the expiration of their terms, to four-year terms starting on July 1 and every four years thereafter.
